■ PROFILE

Carlos Ferran is a Full Professor of Accounting and Management Information Systems at Governors State University, where he has taught since 2010 and served as Director of Accreditation and Assessment. He previously held faculty positions at the Pennsylvania State University and the Rochester Institute of Technology. His research examines technology-mediated communication, generative artificial intelligence in education and the economy, accounting information systems, and the digital divide. The article "Videoconferencing in the Field: A Heuristic Processing Model," published in *Management Science*, was covered by more than 150 news outlets within sixty days of publication, and his conference paper "Teams or Communities? Organizational Structures for Knowledge Management" has been cited in more than three hundred academic articles.

Before entering academia he was Chief Information Officer of a major Venezuelan financial institution, director of a software development company, and a planning and financial analyst in the Venezuelan oil industry; his professional career began writing accounting applications for the Apple II. He completed four of the five years of the Electrical Engineering program at the Universidad Central de Venezuela and the Universidad Metropolitana before redirecting his studies toward management science and finance, and that engineering grounding continues to inform his work on information systems architecture. He is the founding Editor-in-Chief of RELCASI, a journal of the Association for Information Systems, past president of LACAIS and of the AIS Accounting Information Systems SIG, co-chair of AMCIS 2019, and a peer reviewer for the Higher Learning Commission, ABET, Quality Matters, and MERLOT. He has developed more than twenty-five online courses, co-developed an online MBA in Supply Chain Management and a Master's in Business Analytics, and has taught in English and Spanish on four continents.
